January 5, 2010

The regular January Meeting of City Council was held on January 5, 2010 at 7:00 p.m. in the Council Chambers located on the Fourth Floor of the Municipal Building. The following Council Members were present: Ruby B. Archie, L. G. "Larry" Campbell Jr., T. David Luther, Gary P. Miller, Vice-Mayor T. Wayne Oakes, Albert K. "Buddy" Rawley Jr., Mayor Sherman M. Saunders, Fred O. Shanks III, and Adam J. Tomer (9).

INVOCATION AND PLEDGE OF ALLEGIANCE

Mayor Saunders offered the Invocation. The Pledge of Allegiance to the Flag followed.

MINUTES

Council Member Archie moved approval of the Minutes of the December 15, 2009 Regular Meeting of City Council.

Council Member Luther advised a portion of his comments were incorrectly stated in the December 15 Minutes. In the matter relating to a request for a Special Use Permit for a Bed and Breakfast at 284 West Main Street, Mr. Luther stated his comments were "...approved it for two rooms, years ago" and not "approved it two years ago."

City Clerk Crane noted the correction.

Mr. Luther seconded the Motion and the Minutes were approved as amended.

PUBLIC HEARING - SPECIAL USE PERMIT AT 284 WEST MAIN STREET

Mayor Saunders opened the floor for a Public Hearing to consider a request for a Special Use Permit to operate a bed and breakfast at 284 West Main Street. Notice of the Public Hearing was published in the Register and Bee on December 22 and 29, 2009.

The matter had been tabled during the December 15, 2009 Council Meeting following Ms. Brokaw's request during the meeting for a two-room facility rather than the one-room bed and breakfast recommended by the Planning Commission.

Applicant Brenda Brokaw appeared to answer questions from Council Members and citizens. Ms. Brokaw reported she had obtained written permission from her neighbor to allow customers to park on the neighbor's property in order to meet parking requirements for a two-room bed and breakfast. In response to Mr. Shanks, Planning Director Gillie stated he had received the signed agreement and the document was on file in his office.

AN ORDINANCE AMENDING CHAPTER 2 OF THE DANVILLE CITY CODE BY ADDING ARTICLE XVI, ENTITLED "COALITION FOR A SAFE DANVILLE."

Vice-Mayor Oakes called attention to Section 2-246 of the Ordinance entitled "Term." He recalled that during Work Session discussions it was decided the Coalition's initial term would be three years, extended as warranted by City Council. In the Ordinance before Council for consideration, it states the term of the Coalition shall be through December 31, 2013. He stated that

City Attorney Whitfield advised that recently the Virginia Supreme Court reversed a conviction under the City of Virginia Beach's noise ordinance. Because the City's current noise ordinance contains similar language to what the court found objectionable, it has been modified to incorporate new standards set forth in a Report of the Local Government Attorneys of Virginia' Ad Hoc Committee on Noise Ordinances. Mr. Whitfield advised the new language would comply with current case law.

Following considerable discussion by Council Members and the noting of several concerns with the Ordinance as presented, it was decided further discussion would be held during the next Council Work Session.
